# Ohio Department of Transportation Directions

## **From Eastern Part of State:**

Take I-70 West to U.S. 40 (West Broad Street, exit #97).

At bottom of the ramp turn left onto westbound U.S. 40 (West Broad Street).

Go up hill on U.S. 40 to first traffic light; turn right into driveway.

ODOT is the second large building on the right.

Turn left into parking lot; the lobby is located inside the south entrance.

## **From Southern part of the State:**

Take I-71 North to I-70 West

Take I-70 West to U.S. 40 (West Broad Street, exit #97).

At bottom of the ramp turn left onto westbound U.S. 40 (West Broad Street).

Go up hill on U.S. 40 to first traffic light; turn right into driveway.

ODOT is the second large building on the right.

Turn left into parking lot; the lobby is located inside the south entrance.

## **From Western part of the State:**

Take I-70 East, exit at U.S. 40 (West Broad Street, exit #97).

At bottom of the ramp turn right onto westbound U.S. 40 (West Broad Street).

Go up hill on U.S. 40 to first traffic light; turn right into driveway.

ODOT is the second large building on the right.

Turn left into parking lot; the lobby is located inside the south entrance.

## **From Northern part of the State:**

Take I-71 South to I-70 West.

Take I-70 West to U.S. 40 (West Broad Street, exit #97).

At bottom of the ramp turn left onto westbound U.S. 40 (West Broad Street).

Go up hill on U.S. 40 to first traffic light; turn right into driveway.

ODOT is the second large building on the right.

Turn left into parking lot; the lobby is located inside the south entrance.
